CHIEF'S RECOMMENDATION:

INFORMATION FACTORS:

Mr. Peter Matwyuk wrote the letter below to my attention to commend Constables Bradley, Cooke, and Verbeek. This is from an incident involving the passing of Mr. Matwyuk's mother in 2019 when these officers displayed the compassion and empathy that you often hear me speak about with such conviction.

To give you some background my mother had been sick most of my life. In fact, she had been sick most of her own life. When she passed though it was a gong show.

She passed at home, like she had wanted, and since it wasn't planned Belleville Police Service Officers arrived on scene. To make matters more stressful her "yellow folder" wasn't complete like it should have been and to further add to my grey hairs my father had passed away less than 2 years prior.

Thankfully the paramedics on scene made it known how my mother was a regular when officers arrived. Your officers contained integrity throughout. They treated the situation accordingly and when it was confirmed my mother had a DNR and a history of health issues I could see their demeanor change. They immediately became supportive and caring. When the lead paramedic noted I had lost my father not quite 2 years prior I could see the faces of your officer's sink and realize they could not comprehend what I was going through.

When the funeral home was contacted, it was noted to your officers and the paramedics that they would be hours away due to multiple deaths that day.

So, your officers, and one paramedic, stayed with me and my wife. They talked with me. They laughed with me, they cried with me. They took the time to just be with me. They wanted to make sure I was as okay as I could possibly be, as they knew it wouldn't be 100% but wanted to make sure I was okay.

After Steele's came and got my mother, much later into the night, an officer returned to get her medications noting that although I said I would take them to be disposed of in the morning, didn't want me to have to spend my birthday doing that. So, he collected them to ensure that burden was removed from me. He continued to stay with my wife and I just to see how I was, and I was holding up.

So, going back to 2019, while your officers never cleared snow when my mother passed, your officers showed empathy and care. They went above and beyond to show love and care when they didn't need to. Had I known then I could have nominated them for commendations I would have. However, now that I know I can, please, I ask that you consider this a late nomination.

Cst. Dave Bradley, Cst. Steve Cook and Cst. Hans Verbeek are to commended for their commitment to excellence and service to our community. I am incredibly proud of the way that these officers performed their duties, as I am incredibly proud of all our members on a daily basis.

4. **RECOGNITIONS** (10:01 a.m.)

(a) Following receipt of a letter of recognition received from Sergeant Matthew Barker of the Deep River Police Service, Dispatchers Ashliee Brown, Kris Gauthier (absent), Lindsay Rhodes, Darrin Thompson, Kelly Thompson and Claude Vaillancourt appeared before the Board in connection with their outstanding communication skills and professionalism when on, December 11, 2022, they assisted the Deep River Police Service during a homicide investigation.

Chief Callaghan read an excerpt from Sergeant Barker's communication.

"You displayed superb communication skills with me and were instrumental in ensuring I received as much information possible, so the accused was arrested, multiple crimes scenes were properly safeguarded, and the assets I required were received."

(b) Officers Greg Kendall and Jeff Smith (absent) appeared before the Board in recognition of their exemplary efforts in going above and beyond, when on March 4, 2023 they made the notification to an elderly gentleman, whose wife had passed away while on route driving herself to the Hospital.

Chief Callaghan noted that the Officers stayed with the gentleman, who, he himself, had health issues, while he contacted family and took it upon themselves to clear the driveway following a significant snow storm $(20-30\ cm.)$, to allow easy access by the family.

Chief Callaghan stated that the compassion and empathy displayed by the Officers speaks to the attributes members of the Service possess, and noted that our community is fortunate to have Officers of this caliber.

Chief Callaghan noted that Constable Kendall's father, Sergeant Roy Kendall was in attendance.

(c) Inspector Sheri Meeks appeared before the Board in recognition of her tireless efforts in regards to her community service to the Quinte Region, City of Belleville and the Belleville Police Service.

Chief Callaghan stated that the Community Builder Award is one of the highest Awards presented by the Belleville Police Service.

Chief Callaghan noted that Inspector Meeks, a 27 year member of the Belleville Police Service, serves on many Boards and has gone above and beyond in serving our community and has distinguished herself in a multitude of ways such as:

United Way

Inspector Meeks was Chair of the United Way in 2020 and 2021 and has served on the United Way Cabinet for the past 5 years.

Polar Plunge

Inspector Meeks has been Chair of the Belleville Police Service Polar Plunge for the past 3 years, and in 2023 helped raise \$30,000.00 for Special Olympians in our community. Inspector Meeks has also not missed a Special Olympics Torch Run in 27 years.

IMPAC Team

Inspector Meeks has worked for the past 15 years to bring the IMPAC Team to fruition and, due to her commitment, the Belleville Police Service is the only Service in Ontario to have the program completely funded by the Ministry of Health, who has also committed funding for the next 5 years.

Children's Safety Village

Inspector Meeks has been involved and Judged the "Kids Got Talent" event being the largest fundraiser for the Children's Safety Village, and has been on the Board of Directors for the past 7 years.

Chief Callaghan noted that Inspector Meeks' Mother and Husband were in attendance.

On behalf of the Board, Chair Councillor Allsopp thanked the members recognized today for their outstanding service.

Vice Chair Smith noted the reference to the use of 3 Weapons in the Report and inquired if charges are laid if replica weapons are used.

Due to the individuals being young offenders, Chief Callaghan spoke in general context noting that, if an imitation weapon is used in the commission of an offence, then charges would be laid. If it is the individual's first time being involved with the criminal justice system, efforts are made to use a diversion program, while still having the individual challenged to recognize their offence.

(d) 4th Quarter Court Statistics Report

Vice Chair Smith noted that the Report indicated that bail hearings decreased by 21% and asked Chief Callaghan to comment.

Chief Callaghan stated that, at a recent Small and Mid-Size Chiefs of Police conference, bail and bail reform was a topic of discussion.

The Government's and Policing Association's representatives at the conference were made aware that proper bail measures need to be put into place as the status quo is not acceptable. It is unfortunate that it took the death of 5 Officers in 2022 to bring this matter forward, however steps are being taken to ensure bail reform is taken seriously.

In regard to the low number of bail hearings, this matter is out of the Services' hands as the Crown Attorney makes those decisions. Chief Callaghan noted the great working relationship the Service has with the Crown Attorneys and increased dialogue is being undertaken on this matter.

Vice Chair Smith inquired if the increase in car thefts was due to vehicles being unlocked or possibly vehicle theft rings.

As a result of 4 arrests Chief Callaghan reported that vehicle thefts have decreased, two individuals were from an organized auto theft ring operating out of Montreal and two local individuals were stealing vehicles from the Industrial Park area.

Steps have also been taken to source a real time vehicle theft information system which will allow a quicker response to areas of concern, and with the increase in the Officer complement a more pro-active approach will be realized.

Chief Callaghan also noted that Officers receive on-going training to mitigate injuries when attempting to make an arrest.

In reply to a question from Vice Chair Smith, Chief Callaghan stated that the increase in WSIB cases in 2018 relates to the Provincial Government and WSIB's recognition of PTSI/PTSD.

Mr. O'Brien requested Chief Callaghan provide a verbal update on this Report.

Chief Callaghan noted, due to funding and operational issues, small to mid-size Services across the Province often do not have access to a Detox Centre.

Chief Callaghan stated that while intoxicated individuals are currently held in Police cells it must be noted, that Officers are not medical healthcare professionals and the liability is significant. In view of this, meetings with Social Service providers and Healthcare professionals to discuss a Detox Centre in Belleville have been held.

Chief Callaghan noted he is a Board member of the Chamber of Commerce, where he put forward a resolution, now endorsed by the Ontario Chamber of Commerce, to seek funding to have Detox Centres in small and mid-size communities. Our local Members of Parliament, as well as community members have been very supportive.

Chief Callaghan stated he is cognizant of the fact, that this is not a policing issue but more of a societal matter, however, it the Police can act as a catalyst to move the issue forward, it is felt the dynamics of the community will benefit.

Chair Councillor Allsopp thanked Chief Callaghan for identifying this gap in our community and working towards its resolve.

SUBJECT: Success of Body Worn Cameras

CHIEF'S RECOMMENDATION:

For the Board to review and file for information.

INFORMATION FACTORS:

As this matter will be before the courts in the near future, I will have to remain very generic in my explanation of this good news story.

A member of our Patrol Division was responding to a priority #1 Break and Enter in progress call for service at approximately 0230 hrs in the east end of our city. Upon arrival of the officer, the suspect was observed and a foot chase between the officer and the suspect ensued.

The foot chase was quite lengthy, with the suspect and the officer jumping over backyard fences, down alleyways, and over shrubs with the suspect finally being apprehended by the officer in an unknown location.

Upon the suspect being handcuffed and detained by the officer, the officer notified the supervisor that the suspect was in custody and that he required assistance to be picked up by other patrol members. The challenge was that the officer was not aware of his exact location. The patrol supervisor was able to turn on the Axon Responder function, which immediately identified exactly where the officer was, and additional officers were sent to his location forthwith.

This is yet another great example of how important the body worn cameras are with respect to the safety of our members. Prior to body worn camera technology being available, the officer would have had to take out his/her flashlight and point it to the sky while other patrol officers would drive up and down the street looking for the flashlight beam.

I would like to thank the Police Services Board and City Council again for providing our members with this potentially life saving piece of equipment.

SUBJECT: Bail reform necessity

CHIEF'S RECOMMENDATION:

For the Board to review and file for information.

INFORMATION FACTORS:

As you have recently noted in the mainstream media, there has been a significant emphasis on the crisis we are experiencing as it relates to the necessity for a complete overhaul of the bail system.

A concrete example from here in Belleville is outlined below. We will refer to this person as John Doe for the purpose of this report. You will note how many times John Doe has been before the criminal justice system, how he has violated the terms of his conditional release, and how he is still in our community committing criminal offences. This is not an acceptable practice. While in most cases a person on bail does comply with the terms and conditions, there are people like John Doe who require to be incarcerated for the safety of our community and our members.

The information below is snapshot of 11 days with John Doe:

10 March: John Doe arrested at on Forin St for Assault and Threats, held SCH.

13 March: John Doe released on bail, conditions not to return to 20 Forin St. At 2330 hrs, John Doe returned to 20 Forin St, arrested and held for SCH.

15 March: John Doe released on bail, still on conditions not to return to 20 Forin St. At 1651 hrs, John Doe returned to 20 Forin St, arrested and held for SCH.

20 March: John Doe plead guilty to charges (two charges withdrawn, suspended sentence x2 and probation), released from custody.

21 March: John Doe breached probation, returned to 20 Forin St. Held for SCH.

Please note, the home at 20 Forin is run by Enrichment Centre for Mental Health.

This is just one example of many that has the potential for disastrous consequences for citizens of our community. The frustration of the victims and our officers cannot be overstated. It is imperative that the Provincial and Federal Governments work collaboratively to resolve this issue as soon as possible.

SUBJECT: 2023 1st Quarter Traffic Safety Unit Stats

CHIEF'S RECOMMENDATION:

For the Board to review and file for information.

INFORMATION FACTORS:

The Traffic Safety Unit has been very busy backfilling for the frontline and due to staffing challenges, we have had to draw resources from this unit to augment the frontline 911 calls for service.

While we recognize the importance of roadway safety and the important function this unit affords our community, it is operationally imperative to have sufficient human resources available to respond to 911 calls for service.

Synopsis of Unit - January 1st to March 31st 2023

The Traffic Safety Unit (TSU) currently has three constables with one assigned as an acting sergeant. TSU was being supervised by the Inspector of Operations.

TSU Total Charges: 162 Charges

Major Collision Investigations

0 major collisions were investigated by TSU in Q4.

Remotely Piloted Aircraft System (Drone Operations)

- 4 drone operations:
 - o 2 Suspect searches
 - 1 Search and rescue
 - 1 Assist other agencies (BFD, OPP, CN Police, other agency, Etc.)

Traffic Initiatives

TSU received traffic complaints related to speed in both Ward 1 and 2. Speed Spy was used to collect data in most areas, and a problem area was identified on Ashley Street in Foxboro. Enforcement efforts were initiated in the location and several violators were charged.

TSU implemented a traffic safety initiative called "March Mash Up" from March 20th to the 30th. The initiative was implemented based on the complaints received by the community, mostly related to speed.

A total of 86 charges were issued. Some charges to highlight were insecure loads, obstructed plates, improper tires, and stunt drive where a driver was caught doing 104km/hr in a 60km/hr zone.

Training

TSU was tasked with training and requalifying front-line patrol officers in radar and lidar and further provided annual in-service training for all breath technicians.


When we look at the top ten calls for service for the 1st quarter of 2023, we see an increase of 14% or 827 calls more than in the same time period of 2022.


The area that we are continually seeing the increase is in 911 hang-ups and unwanted person calls for service. To combat this, we are meeting with a local radio station in an effort to provide public service announcements to counter this problem. We are looking at innovative opportunities to educate the public in this area, with the hopes of reducing these unnecessary calls for service.

With respect to unwanted person calls for service, we actually expect these numbers to increase as we know that there is an increase of those suffering from homelessness residing in the Belleville area during the summer months. We have made a significant investment in staffing resources to work with those suffering from homelessness in an effort reduce these calls for service, while at the same time assisting those in need in our community.


Total Calls for Service




Top Ten Calls for Service

SUBJECT: COURT STATISTICS - 1ST QUARTER REPORT 2023

CHIEF'S RECOMMENDATION:

For the Board to review and file for information.

INFORMATION FACTORS:

Court Office

The Court unit liaises with the Crown Attorney, Court Administrator, Provincial Prosecutors, Probation Office and Victim/Witness Services as well as other police and civilian agencies with the view of ensuring police charges are properly prepared and processed through the courts. They are also responsible for providing service in relation to serving court-related documents, court appearances, bail hearings, trials, transfer of charges as well as maintaining accurate and timely records on Niche and CPIC. Members of the unit are in frequent contact with a host of other police services and agencies such as the Judiciary, Defence Counsel, Court Administrative Staff, public and private agencies regarding victims and offenders as well as the general public. The Unit prepares Criminal Code information for charges stemming from court matters (i.e. failure to appear in court), prepares charges on behalf of the probation officer, and notifies and cancels witnesses as required. Additionally, the unit ensures that Crown instructions for pending court proceedings are relayed to officers.


During the first quarter of 2023, 90 Criminal Code charges were processed and laid by the Court office staff compared to 105 during 2022.


What is a bail hearing?

If police do not release the person who has been arrested, they must bring the person before a justice for a bail hearing within 24 hours or as soon as possible. A bail hearing is a procedure where a judge or a justice of the peace determines whether a person charged with an offence should be released or held in custody pending trial. On the appearance

date, the accused may enter into a consent release situation whereby certain conditions are agreed upon and must be followed, elect to run a hearing to be released if there is no consent by the Crown for release, or ask that the hearing be adjourned in order to find a suitable surety to attend court to assist with the release conditions and supervising the accused.

During the first quarter of 2023, there were a total of 329 instances where an officer was required in court with regard to a bail hearing being scheduled, whether it was a first appearance or an additional appearance due to an adjournment, compared to 261 in 2022.





Court Security - Special Constables


Special Constables are civilian members who play an important role within the Belleville Police Service. Once hired, the Chief of Police swears in members as Peace Officers. Special Constable is a designation issued by the province of Ontario providing members with a limited Law Enforcement role in the City of Belleville.

The Special Constables ensure the security of Justices, Judges, Justices of the Peace, Court staff, all occupants of the courthouse, all persons taking part in or attending court proceedings, and the security of court buildings during the hours when the courts are operating. They provide professional care, custody, and transportation of people who are in custody from various detention facilities as well as anyone taken into custody during court proceedings. The unit escorts prisoners within the courthouse to ensure timely, safe and secure appearances in the required courtrooms.

Special Constables are responsible for fingerprinting and gathering DNA samples for the DNA Data Bank. Under the Canadian Criminal Code, judges can order those convicted of designated offences to provide samples for DNA analysis. Young offenders can be included in the DNA Data Bank. The DNA Data Bank helps investigators identify suspects, link crime scenes where there are no suspects, eliminate suspects, and determine if a serial offender may be involved in a crime. DNA kits are prepared by the RCMP National DNA Data Bank and supplied to the Service. The Special Constable has to take the offender's fingerprints and blood droplets for submission. The Special Constables are also used for special events, subpoena service, ground searches, and any other duties assigned by the supervisor to assist other units. The Unit completed 15 DNA court-ordered samples in the first quarter of 2023 compared to 10 samples taken in the first quarter of 2022.

As part of the Court Security Plan, Special Constables staff the entrance of the courthouse to operate the magnetometer and x-ray machine in order to screen individuals entering the courthouse. They are looking for any items that may pose a security risk such as guns, knives, scissors, etc. If an item is found, the individual is given the option of removing it from the courthouse to allow entry or forfeiting it for destruction.






The Quinte Courthouse serves two Police Services, four OPP detachments and the Military Police within the County of Hastings: Belleville Police Service, Tyendinaga Police Service, Quinte West OPP, Centre Hastings OPP, North Hastings OPP and Prince Edward County OPP (for bail hearings only) and the CFB Trenton Military Police.


Prisoner transportation is shared between the Belleville Police Service and Quinte West OPP who supply two Special Constables to operate their prisoner transport vehicle. There is the requirement to attend at the Quinte Detention Centre (Napanee) in the morning to pick up prisoners and then to return the prisoners at the conclusion of court. On a weekly rotation basis, Belleville Police Service is responsible for either the morning transport or the afternoon.

The following graphs indicate the number of prisoners transported during the first quarter of 2023 for a total of 232 (81 in 2022) prisoners; 150 (70 in 2022) Belleville Police Service prisoners, and 82 (11 in 2022) prisoners for the other services and OPP detachments.






The following graphs indicate the number of prisoners handled at the Quinte Courthouse. This is where a prisoner is arrested the day before or day of the court appearance. The prisoner is not transported on the escort wagon and would not be captured in the transportation stats. In this case, the prisoner would attend the courthouse to be housed, escorted to the courtroom, and released.

In the first quarter of 2023 the number of prisoners transported was 232 compared to 289 prisoners handled.

The following graphs indicate the number of prisoners handled during the first quarter of 2023 for a total of 289 (102 in 2022) prisoners; 193 (89 in 2022) Belleville Police Service prisoners, and 96 (13 in 2022) for the other services and OPP detachments.

SUBJECT: CRIME STATISTICS – 1ST QUARTER REPORT 2023

CHIEF'S RECOMMENDATION:

INFORMATION FACTORS:

Total Crimes:

During the first quarter of 2023, there were 1,097 crimes reported (92 unfounded) for an actual of 1,005 "crimes" compared to 1,040 reported during the first quarter of 2022. This represents a 5% increase in reported crimes.

Homicides:


There were no homicides reported in the first quarter of 2023 or 2022.

Weapons Offences:

There were a number of incidents involving offensive weapons. The first quarter of 2023 had 37 reports (3 unfounded) compared to 23 (1 unfounded) in 2022. This indicates a 61% increase in weapon calls.

Robberies:

In the first quarter of 2023, 4 robberies were reported compared to 9 robberies reported during the same time period in 2022. This represents a 55% decrease.

Break and Enters:

During the first quarter of 2023, there were 65 break and enters reported (7 unfounded) for an actual of 58. This represents a 33% increase in break and enters compared to 49 (7 unfounded) reported in the first quarter of 2022.

Motor Vehicle Thefts:

There were 31 reports of motor vehicle thefts (3 unfounded) for an actual of 28 during the first quarter of 2023. In the first quarter of 2022, there were 25 reported motor vehicle thefts (5 unfounded) which represents a 24% increase over last year.

Assaults:

There were 100 assaults reported in the first quarter (12 unfounded) for an actual of 88 compared to 68 (3 unfounded) with an actual of 65 assaults reported for the same period in 2022. This represents a 47% increase in assaults reported.

Sex Offences:

During the first quarter of 2023 there were 42 sexual offences reported (3 unfounded) for an actual of 39. This is a 16% decrease from the first quarter of 2022 which had 50 (6 unfounded) sexual offences reported in 2022.

Frauds:

There were 77 frauds reported (9 unfounded) for an actual of 68 during the first quarter of 2023. This represents a decrease of 21% in frauds reported compared to last year where 98 frauds were reported (3 unfounded) for an actual of 95.

Drug Offences:

There were 21 drug offences reported (1 unfounded) for an actual of 20 reported in the first quarter of 2023. This is an 86% decrease from last year where 39 drug offences were reported (0 unfounded) during the same time frame in 2022.

Criminal Harassment:

There were 49 criminal harassment incidents (17 unfounded) for an actual of 32 incidents reported in the first quarter of 2023. This represents a 32% increase in criminal harassment incidents compared to 37 (4 unfounded) reported in 2022.

Utter Threats:

There were 34 incidents reported (7 unfounded) for an actual of 27 during the first quarter of 2023. This is a 6% increase compared to 32 (2 unfounded) incidents reported in the first quarter of 2022.

Arson:

There were 3 incidents of arson reported in the first quarter of 2023. This is a 200% increase from last year where 1 incident of arson was reported during the first quarter of 2022.

ViCLAS (Violent Crime Linkage Analysis System):

There were 23 ViCLAS submissions for both criteria and non-criteria offences identified in the first quarter of 2023. This is a 15% increase over last year where 20 ViCLAS submissions were captured during the first quarter of 2022.

- Of the 21 criteria offences, all ViCLAS submissions were for Sexual Assault incidents (7 of the Sexual Assaults resulted in charges and 8 investigations are still ongoing).
- Of the 2 remaining non-criteria offences, one ViCLAS submission was for Threats and the other submission was for an Indecent Act.

Presentations/Training:

On January 26, 2023, Detective Constable Earle-Dempsey presented an informative 2-hour session to 25 new C.A.S. (Children's Aid Society) intake workers. They were educated on the Belleville Police Service policy and procedures of handling domestic and H.A.R.T. (High Risk Action Review Team) calls for service.

On March 29, 2023, Detective Constable Hatfield met with the Bethel-Zion Women's Institute and educated the group on Human Trafficking. Some topics discussed included; the trafficking lingo and catch-phrases used by involved parties, the number of people (potential clients) entering and exiting a hotel room as an indicator and signs or changes in behaviour to be aware of in females being human trafficked. The presentation was well received with numerous attendees.

For the first quarter of 2023, you will note that we are in line with our budget projections for both our capital and operational budgets.

The continuing challenge in our capital budget is to acquire new police package vehicles as the production schedule for these items at best is very uncertain. From speaking with other police agencies across Ontario, this is very common to them as well.

We are confident that we are meeting our operational budget projections and have not experienced anything to date that leads us to believe we will not be in line with our budgeted expenses.
