Building on the foundation of the 30 by 30 initiative, the 30 Forward initiative reflects a distinctly Canadian approach to advancing gender representation in policing. It recognizes that achieving 30% representation is not the finish line; it is a benchmark from which we continue to progress.

Participation in 30 Forward does not mean lowering standards, excluding men from opportunities, or hiring unqualified candidates. Rather, it affirms our commitment to



equitable recruitment, retention, and advancement practices that strengthen our service and the communities we serve.

The Belleville Police Service is proud to be among the initial signatories of the 30 Forward Pledge, an initiative dedicated to building a more inclusive and effective policing profession. On October 9, 2025, the official launch took place with twelve services joining the pledge, signing in person, and reaffirming a shared commitment to supporting women in policing.

As part of this commitment, we will be reviewing our policies, procedures, practices, and culture to identify opportunities to better support all members of our organization.

Our participation in 30 Forward represents a meaningful step toward a stronger, more inclusive Service and deeper trust with our community.

Quick Facts:

In 2024, the percentage of female sworn officers in the Belleville Police Service rose to 26%. A significant milestone that reflects our commitment to diversity, inclusion, and strengthening our Service through representation.
